OF

Pursuant to Florida Statute 617.0202 the undersigned files these Articles of Incorporation for the **STAR INTERNATIONAL BASEBALL, INC.**, a Florida non-profit corporation and states:

**ARTICLE I**

The name of the corporation is **STAR INTERNATIONAL BASEBALL, INC.**

**ARTICLE II**

**ARTICLE III**

The purpose for which this corporation is organized is to establish, oversee, or otherwise participate in amateur athletic programs specifically relating to the sport of baseball, including but not limited to, T-Ball, Little League, Khoury League, American Legion Baseball and Adult Recreational Baseball.

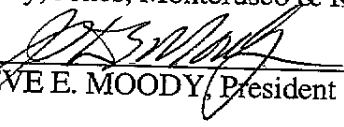

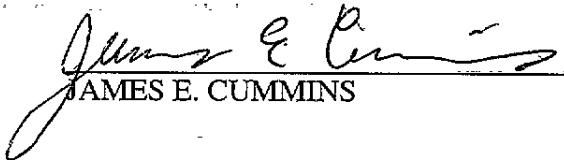
The corporation hereby designates MOODY, JONES, MONTEFUSCO & KRAUSE, P.A. as Registered Agent for service of process.

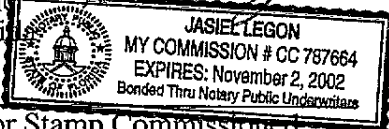
