

SECOND AMENDMENT TO ARTICLES OF INCORPORATION FOR GRANDEZZA PRESERVE ASSOCIATION, INC.

GRANDEZZA PRESERVE ASSOCIATION, INC. (a Florida not-for-profit corporation)
