**ARTICLES OF INCORPORATION**  
**LITTLE LEGENDS INFANT CENTER ADULT DAY CARE, INC.**

ONE: The name and address of this principal corporation is Little Legends Infant Center Adult Day Care Inc., located at 5532 Community Oaks Court, Jacksonville, Florida 32246, in Duval County. The principal office is also the mailing address. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for, charitable and educational purposes to aid the poor and disadvantaged individuals and families toward a life of self-sufficiency. The programs will consist of but shall not be limited to: Land, Acquisition, Counseling, To provide Child Care Services, Tutoring Adult Day Care, Care for disabilities, Twenty-Four Hour Day Care, Teen Job Placement, Teenage Pregnancy, Tutoring, Summer Camp, Community Employment, Before & After School Care, class/homework assistance, Computer Lab, Drama and Arts, Music, Seminars, Health Fairs, Aids/HIV Education, Drug Awareness, Rehabilitation of clients back into society, and other programs to aid those in need.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.


