ARTICLES OF INCORPORATION

OF

LOVE IS INC.

A Florida Not-For -Profit Corporation

We, the undersigned, with other persons being desirous of forming a Florida not-for-profit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I.

The name of this corporation is: LOVE IS INC.

ARTICLE II.

The principal place of business and the mailing address of this corporation shall be 1021 N. Pinehills Road, Orlando, Florida 32808.

ARTICLE III.

The general purpose of the business or businesses to be transacted by this corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida is educational. The purpose of this corporation shall include the ability to make charitable contributions. The purpose for which the corporation is organized is exclusively charitable and educational within the meaning of

section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these Articles of Incorporation, this corporation shall not carry on any activities not permitted to be carried on by a corporation that is exempt from Federal income tax under 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE IV.

The Board of Directors shall manage the business of the corporation. This corporation shall have seven directors, initially. The number of directors may be increased from time to time by the bylaws, but shall never be less than three. All board members shall be at least 18 years of age or older. The Board of Directors shall be appointed and hold office in accordance with the bylaws.

The membership of this corporation shall constitute all persons hereinafter named as officers and directors of such other persons who from time to time may become members by a majority vote and according to the bylaws.

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment thereto, by a majority vote and in accordance with the bylaws.

ARTICLE V.
