**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
CAMBRIDGE CHRISTIAN SCHOOL, INC.**

Pursuant to Sections 617.1002 and 617.1006, Florida Statutes, CAMBRIDGE CHRISTIAN SCHOOL, INC., a Florida not for profit corporation (the "Corporation"), whose Articles of Incorporation were originally filed with the Florida Department of State, Division of Corporations, on September 25, 2000 (Florida Department of State Document Number N00000006341), hereby amends the Corporation's Articles of Incorporation according to these Articles of Amendment:

1. The name of the Corporation is CAMBRIDGE CHRISTIAN SCHOOL, INC.

2. The Articles of Incorporation of the Corporation are hereby amended by deleting the present form of Article II(b), and by substituting, in lieu thereof, the following:

"(b) In addition to the general Charitable Purposes described in the foregoing paragraph (a), the specific Charitable Purposes are the formation and operation of a college-preparatory educational institution offering preschool, elementary, and secondary instruction to children through grade twelve within an environment of Evangelical Christian faith as expressed in the Cambridge Christian School Statement of Faith and utilizing the Holy Scriptures as the ultimate standard for faith and practice."

3. The Articles of Incorporation of the Corporation are hereby amended by deleting the present form of Article III(f), and by substituting, in lieu thereof, the following:

"(f) Increase, by a vote of its Trustees cast as the Bylaws may direct, the number of its Trustees so that the number shall not be less than seven (7)."

4. The Articles of Incorporation of the Corporation are hereby amended by deleting the present form of Article VI(a), and by substituting, in lieu thereof, the following:

"(a) The affairs of the Corporation shall be managed by a Board of Trustees, which shall consist of not less than seven (7) persons. The number of Trustees in excess of seven (7) shall be as set forth in the Bylaws. The Trustees shall be elected or removed in accordance with the procedures provided in the Bylaws."

5. The foregoing amendments to the Corporation's Articles of Incorporation shall become effective on the date these Articles of Amendment are approved by the Florida Department of State and all filing fees then due have been paid, all in accordance with the not for profit corporation laws of the State of Florida.

6. There are no members of the Corporation. The foregoing amendments to the Corporation's Articles of Incorporation were adopted by the Board of Trustees of the Corporation on November 22, 2023 pursuant to a written consent executed by all members of the Board of Trustees of the Corporation.




