Article I: Name

The name of this corporation shall be CHICKEE CHRISTIAN ACADEMY, INC.

Article II: Principal Office

The principle office and mailing address of this corporation shall be 2910 N. 64th Ave., Hollywood, FL, 33024.

Article III: Purpose

This corporation is organized exclusively for religious, charitable, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue code of 1986 (or corresponding provision of any future United States Internal Revenue law), including, but not limited to, for such purposes, the establishment and maintenance of a Christian School for pre-school through post high school students.

To confer certificates, diplomas, and degrees upon completion of established requirements for such purposes.

To acquire property by grant, gift, purchase, devise or bequest, and hold and dispose of such property as the corporation call require.

The foregoing purposes shall be construed as both objects and powers and foregoing enumeration of the specific purposes shall not be held to limit or restrict in any manner the powers of this corporation.

Notwithstanding any other provisions of these Articles, this corporation shall not carry on any activities not permitted to be carried on by and organization exempt from federal income tax under Sections 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

Article IV: Election of Directors

The Directors of this corporation shall be the elected directors of Chickee Baptist Church of Hollywood, Florida Inc. as prescribed by the Constitution and By-Laws of Chickee Baptist Church of Hollywood, Inc.

No part of the net earnings of this corporation shall inure to the benefit or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the tax-exempt purpose of the corporations set forth in article III.

Article VII: Political Activities

No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Article VIII: Racial Nondiscrimination

This corporation shall have a racially nondiscriminatory policy and therefore shall not discriminate against applicants, students, employees, and others on the basis of race, color, or national or ethnic origin.

Article IX: Dissolution

Upon the dissolution of the corporation, the board of directors shall, after paying or making provision for payment of all the liabilities of the corporation, transfer all assets to Chickee Baptist Church or other church or churches of like faith and practice.

Article X: Amendments

This Articles of Corporation may be revised and amended by a majority vote of the board of directors at any meeting of the board of directors.
