ARTICLES OF INCORPORATION

Article I. NAME

The name of this corporation shall be, LEARNING EXCELLENCE FOUNDATION OF ORANGE COUNTY, INC. (hereinafter called the "Corporation").

Article II. PRINCIPAL OFFICE AND/OR MAILING ADDRESS
