ARTICLES OF INCORPORATION

(A Florida Net-For-Profit Corporation)

Article I. NAME

The name of this corporation shall be, LEARNING EXCELLENCE FOUNDATION OF BOGGY CREEK, INC (hereinafter called the "Corporation").
