ARTICLES OF INCORPORATION
of

(A Florida Not-For-Profit Corporation)

Article I.
NAME

The name of this corporation shall be, **LEARNING EXCELLENCE FOUNDATION OF BOGGY CREEK, INC.** (hereinafter called the "Corporation").

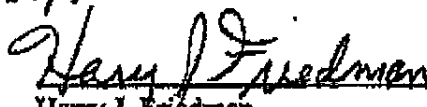
