## Article I.

The name of this corporation shall be, LEARNING EXCELLENCE FOUNDATION OF TAMPA, INC. (hereinafter called the "Corporation").

## Article II. PRINCIPAL OFFICE AND/OR MAILING ADDRESS

## Article III. PURPOSE

This Corporation is a not-for-profit corporation, organized for charitable and educational purposes, including owning and operating charter schools, and doing all things related thereto.
