**ARTICLE I - NAME**

The name of this Corporation is PRESIDENTIAL COUNCIL ON LIFESTYLES, INC.

**ARTICLE II - PRINCIPLE OFFICE**

The street address of the initial principle office the Corporation is 3660 West Commercial Boulevard, Fort Lauderdale, Florida 33309, and the mailing address of the Corporation is P. O. Box 81-1901, Boca Raton, Florida 33481.

**ARTICLE III - PURPOSE**

The purpose for which the Corporation is organized is as permitted pursuant to Chapter 617 of the Florida Statutes and may provide, among other non-profit purposes permitted under the statute, a non-profit, social and intellectual facility for adults who engage in alternate lifestyles, or meet to exchange ideas and/or socialize regardless of sexual orientation, and to support others of like persuasion.

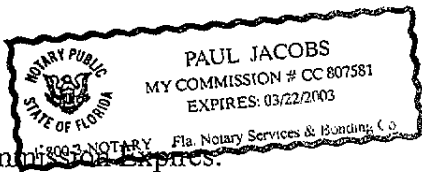
