ARTICLES OF INCORPORATION OF FRIENDS OF ST. MARTIN DE PORRES CORPORATION (A corporation not-for-profit)

The undersigned, for the purpose of forming a Not-for-profit Corporation pursuant to Chapter 617 of the Florida Statutes, hereby certify as follows:

ARTICLE I. NAME

- To apply for and receive grants, to borrow money, and, from time-to-time, to make, accept, endorse, execute, and issue bonds, debentures, promissory notes, bills of exchange, and other obligations of the Corporation for moneys borrowed or in payment for property acquired or for any of the other purposes of the Corporation, and to secure the payment of such obligations by mortgage, pledge, deed, indenture, agreement, or other instrument of trust, or by other lien upon, assignment of, or agreement in regard to all or any part of the property, rights, or privileges of the Corporation wherever situated, whether now owned or hereafter to be acquired.
