## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SOUTHEAST SATSLAB CONSORTIUM, INC.

1. Article III of the Articles of Incorporation of Southeast Satslab Consortium, Inc. shall be amended to read as follows:

## Article III

## **PURPOSE**

- A. The purpose for which the corporation is organized is to support, provide leadership, organize and assist the conduct of studies, technical research, product development, experiments, and demonstrations for the development of a small aircraft transportation system (referred to as SATS), and to secure public and private funding for said efforts of the Corporation to enable economic growth and business opportunities. The Corporation shall participate with companies, government agencies, and other not-for-profit institutions in ongoing research, technology development, and awareness campaigns for the continued development and demonstration of the system.
- B. The purposes for which this organization is organized are exclusively charitable, scientific, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- C. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- D. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be

distributed to the Federal, state, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

The foregoing amendment was adopted by the members of the Board of Directors of the corporation as of 2/25/02, 2002. There are no members entitled to vote on the amendment.
