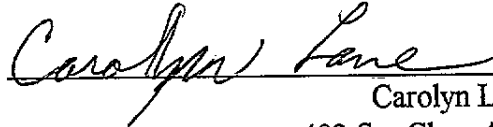

- ARTICLE I** The name and address of this principal corporation is House of Love, Inc., 403 South Clara Avenue, DeLand, Fl. 32720. Volusia County. The corporation is organized pursuant to the **FLORIDA** Nonprofit Corporation Code.
- ARTICLE II** This corporation is a nonprofit community development corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consists of, but shall not be limited to: Job Training, Job Placement, Land Acquisition, Housing, Employment, Literacy, Counseling, Temporary Shelter, Teenage Pregnancy, Family Planning, Mentoring, Substance Abuse and Awareness, and AIDS Awareness programs to those in need.
- ARTICLE III** The duration of this corporation shall be perpetual, no stock and shall have no members.
- ARTICLE IV** The address of the Registered office is 403 South Clara Avenue, DeLand, Fl. 32720. The REGISTERED AGENT at the office shall be:

- ARTICLE V** This corporation is organized and operated exclusively for **Religious, Charitable, and Educational** purposes within the meaning of Section 501{c}{3} of the Internal Revenue Code

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a


corporation exempt from federal income tax under the Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

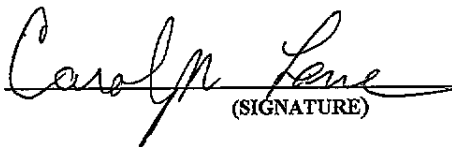
