**ARTICLES OF INCORPORATION OF**

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of the corporation shall be SUNCHASERS MOTORCYCLE CLUB, INC.

**ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**

The name and street address of the initial registered agent is: Samuel L. Ferguson, 521 Division Street, Daytona Beach, FL 32114.





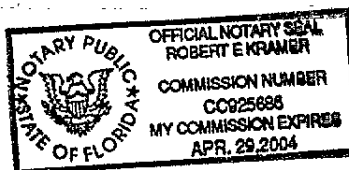
