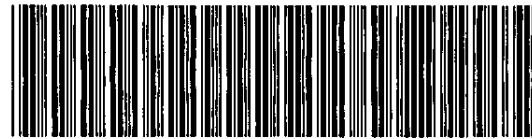



## ARTICLE VIII: DISSOLUTION

- (a) **Section 1.** Upon the dissolution of *Peniel Missionary Christian Church Working United for Christ, Inc.*, the Board of Directors shall, after the payment of all the liabilities of the *Peniel Missionary Christian Church Working United for Christ, Inc.* dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization, or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall qualify as an exempt corporation or organizations under Section 501 ( c) (3) of the Internal Revenue Code of 1986, as amended ( or of the corresponding provisions of any future United States Revenue Law) as the Board of Directors shall determine.
- (b) **Section 2.** No part of the net earnings of *Peniel Missionary Christian Church Working United for Christ, Inc.* shall inure to the benefit of, or be distributable to, its members, officers, directors, or any person except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered, and to make payments in the furtherance of *Peniel Missionary Christian Church Working United for Christ, Inc.*. Notwithstanding any other provisions of the Articles of Incorporation of *Peniel Missionary Christian Church Working United for Christ, Inc.* or these Bylaws, *Peniel Missionary Christian Church Working United for Christ, Inc.* shall not carry on any activity not permitted to be carried on (a) by a Corporation exempt from Federal Income Tax, under Section 501( c) (3) of the Internal Revenue Code of 1986, as amended, (or by the corresponding section of any future Revenue Code of the United States of America) or (b) by a corporation, contributions of which are deductible under Section 170 ( c) (2) of the Internal Revenue Code 1986, as amended (or the corresponding section of any future United States Revenue Law).
