We, the undersigned incorporators of this corporation under Florida Statute 617, as amended, Adopt the following Articles of Incorporation.

ARTICLE I - NAME

*The name of the incorporation is:
JJ INGS ENTERPRISE, INC.*

ARTICLE II - PURPOSE

- (A) The purposes for which the corporation is organized are EXCLUSIVELY: Charitable, Scientific, Literary, Training and Educational - within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1996 or the corresponding provision of any future United Internal Revenue Law.*
- (B) Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501 (c) (3) of the Internal Revenue code of 1986 or the corresponding provision of any future United States Law.*
- (C) Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1996, or corresponding section of any future Federal Tax Code, or shall be distributed to the Federal, State or Local government for a public purpose. Any such assets not so disposed of shall be disposed of by the court of commons Pleas of the county in which the principal office of the organization is then located exclusively for such purposes.*

ARTICLE III - DURATION

The period of the duration of this corporation is perpetual unless dissolved according to law. Corporate existence shall commence upon filing with the Secretary of State.

ARTICLE IV- DIRECTORS

The requirements for directors and the manner of their admission are provided for the By-laws and Charter.

ARTICLE V - PRINCIPAL OFFICE AND REGISTERED AGENT

The street address of the initial principal office of this corporation is: 1828 Daytona Lane North, Jacksonville, Florida 32218-3494. The Name of the initial registered agent of the corporation is: James E. Ings.

ARTICLE VI - INDEMNIFICATION

This corporation shall indemnify any officer or trustee to the full extent permitted by law.

ARTICLE VII
