Articles of Incorporation

Article I Name

The name of the corporation shall be: Grayton Beach Neighborhood Association Inc.

Article II Principal Office

Article III Purpose

The Associations purpose will be to represent the majority view of Association members regarding future development, neighborhood improvements, local issues and environmental concerns, and to communicate with Association members regarding relevant issues.

Article IV Manner of Election

Initial Directors were appointed by acclamation at the first meeting of the neighbors of Grayton Beach, at the Walton county TDC building, Feb. 5, 2000.
