ARTICLES OF INCORPORATION

OF

MISSIONAIRE WORLDCHURCH
CORPORATION

The undersigned incorporator hereby adopts the following articles of incorporation to charter a religious, charitable, nonprofit church corporation, pursuant to Florida Statutes, Section 617 (2000).

1. NAME. The name of this religious, charitable, nonprofit church corporation is MISSIONAIRE WORLDCHURCH CORPORATION.

2. TERM. The term and duration of this religious, charitable, nonprofit church corporation is perpetual.

3. OBJECTS AND PURPOSES. The objects and purposes of this religious, charitable, nonprofit church corporation are:

(a) to promote, organize, establish or operate MISSIONAIRE WORLDCHURCH(ES) and HOLY SPIRIT CLUB(S) in furtherance of the Gospel and Commission of Jesus Christ;

(b) to promote, provide, or conduct religious worship, instruction, missions, and related activities;

(c) to instruct, guide, and advance spiritual growth and enlightenment of the membership and world community;

(d) to promote, organize, establish, operate or endow schools, colleges, universities, seminaries and other institutions or entities connected therewith of a religious, educational, charitable and benevolent character;

(e) to educate, prepare, ordain or appoint persons for missionary service;

(f) to engage in any lawful act or activity in furtherance of these objects and purposes.

4. MEMBERS. A person may qualify for membership of this religious, charitable, nonprofit church corporation, who:

(a) Recognizes, honors, praises, and worships the Lord God Almighty, Jesus Christ His Son, and the Holy Spirit;

(b) Admits sins and the need for repentance of sins toward Lord God Almighty;

(c) Believes and accepts Jesus Christ as Savior and Lord;

(d) Confesses and forsakes sins unto redemptive salvation;

(e) Receives indwelling of the Holy Spirit, a seal or mark of reconciliation to God with a guarantee of irrevocable salvation and life eternal in the Kingdom of God;

(f) Observes rites taught and instituted by Jesus Christ;

(g) Agrees to be governed by the inspired scriptures of the Bible as the Word of God, which was taught, preached, and practiced by Jesus Christ;

(h) Embraces transcultural and social diversities within the MISSIONAIRE WORLDCHURCH(ES) and HOLY SPIRIT CLUB(S) in worldwide missions, regardless of age, race, ethnic, nationality, social, class, economic, political, gender, sexual orientation, handicap, impairment, disability, or any other discriminate practice, custom or conduct inconsistent with the Gospel and Commission of Jesus Christ; and

(i) Commits to be a "Missionaire," a person desiring and seeks spiritual wealth in the Kingdom of God, through "Fruits of the Spirit" in service to others by generously giving time, talents, financial resources, or otherwise in furtherance of the Gospel and Commission of Jesus Christ.

Admission protocol and procedure, rights of members, any quorum and voting requirements for meetings and activities of members, and notice requirements sufficient to provide notice of meetings and activities of members are set forth in the bylaws.

5. DIRECTORS. The business and affairs of this religious, charitable, nonprofit church corporation shall be under the direction of the Board of Missionaire Directors, consisting of not less than three nor more than twenty-five members, who shall be elected by the members at the annual meeting and the method of election of directors are to be set forth in bylaws. Each director shall hold office for term elected and until a successor has been elected and qualified unless occurrence of an earlier resignation, removal from office, or death. Initial Board of Missionaire Directors shall have three members with additional members to be prescribed by the bylaws from time to time.

6. OFFICERS. Officers of this religious, charitable, nonprofit church corporation shall be elected by the Board of Missionaire Directors at its annual meeting. Officers shall serve until the next annual meeting of Board of Missionaire Directors unless occurrence of an earlier resignation, removal from office, or death.

7. BYLAWS. The bylaws of this religious, charitable, nonprofit church corporation shall be adopted by the Board of Missionaire Directors. The power to alter, amend, or repeal the bylaws or adopt new bylaws shall be vested in the Board of Missionaire Directors. Bylaws may contain any provision for the regulation and management of the affairs and business of this religious, charitable, nonprofit church corporation not inconsistent with law or these Articles of Incorporation of MISSIONAIRE WORLDCHURCH CORPORATION.

8. AMENDMENTS. Amendments to these Articles of Incorporation of MISSIONAIRE WORLDCHURCH CORPORATION may be adopted by two-thirds vote of members present at any annual meeting of this religious, charitable, nonprofit church corporation.

9. ASSETS. MISSIONAIRE WORLDCHURCH CORPORATION as a religious, charitable, nonprofit church corporation shall issue no stock. No part of the net earnings of this corporation shall inure to the benefit of or be distributable to its members, directors or other private persons except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its objects and purposes. This corporation shall not carry on any activities not permitted to be carried on by a religious, charitable, nonprofit corporation exempt from United States income tax under Section 501(c)(3) of the Internal Revenue Code of 2000 or the corresponding provision of any future United States internal revenue law. On the dissolution of this religious, charitable, nonprofit corporation, the Board of Missionaire Directors shall dispose of all of the assets of this corporation exclusively for the objects and purposes of this corporation in the manner or to the organization or organizations that are organized and operated exclusively for religious, charitable, educational, or scientific purposes.
