ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of this corporation shall be: Capitol Worship Centre - Jacksonville, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

10401 Old St. Augustine Road, Jacksonville, FL 32256

ARTICLE III PURPOSE

The purpose for which this corporation is organized is to:

- (a) operate exclusively for religious, charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code") and specifically as a church, and exercise all rights and powers conferred by the laws of the State of Florida upon a nonprofit corporation.
- (b) receive contributions from whatever source, whether unrestricted or for designated purposes, and hold the same for such designated purposes or subject to any conditions specified in the terms of the gift or grant and in furtherance of the purposes of this corporation set forth in subparagraph (a) above.

No substantial part of this corporation shall carry on propaganda or otherwise attempt to influence legislation, except as otherwise provided in Subsection 501(h) and Section 4911 of the Code, as amended, and the regulations as they now exist or as they may hereafter be amended. This corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office. Notwithstanding any of the provisions of these Articles of Incorporation, this corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from taxation under Subsection 501(c)(3) of Code, and its regulations as they now exist or as they may hereafter be amended, or by any organization, contributions to which are deductible under Subsections 170(c)(2), 2055(a)(2), 2106(a)(2), 2522(a)(2), and 2522(b)(2) of the Code, as amended, and regulations as they now exist or as they may hereafter be amended. No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to its members,

officers, directors or other private persons except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article III.

ARTICLE IV MANNER OF ELECTION

The manner in which directors are elected or appointed:

In accordance with this corporation's Bylaws, directors are appointed from the membership of the Church by the Pastor and the Elders, with the assistance of the Board of Directors of the Conference of Capitol Worship Centre Churches.

ARTICLE VI DISSOLUTION

In the event that this corporation shall be dissolved or wound up at any time, then all of the properties, monies, and assets of this corporation remaining after provision has been made for payment of its known debts and liabilities as provided by law, shall be distributed to the Conference of Capitol Worship Centre Churches, or any legal successor thereof, so long as the Conference of Capitol Worship Centre Churches (or its successor) remains organized and operated for exclusively religious, charitable and/or educational purposes within the meaning of Section 501(c)(3) of the Code. In the event that the Conference of Capitol Worship Centre Churches (or its successor) is no longer organized and operated for such purposes, all of the remaining properties, monies, and assets of this corporation shall be distributed to such nonprofit organizations which are organized and operated exclusively for the purposes set forth in Section 501(c)(3) of the Code as the Board of Elders of this corporation

shall determine. No private individual shall share in the distribution of any corporate assets upon dissolution of this corporation.

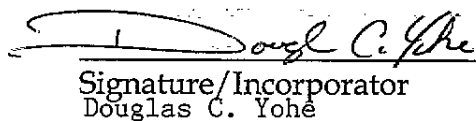
