# ARTICLES OF INCORPORATION

# CORAL COVE PROPERTY OWNERS ASSOCIATION, INC.

The undersigned incorporator hereby adopts the following Articles of Incorporation for the purposes of forming a not-for-profit corporation under the "Florida Not-For-Profit Corporation Act."

# **ARTICLE I**

The name of this corporation is CORAL COVE PROPERTY OWNERS ASSOCIATION, INC. (hereinafter the "Association"). The principal address for the office of the Association is 5800 Gasparilla Road, #B-1, Boca Grande, Florida 33921, and the mailing address of the Association is P.O. Box 1, Placida, Florida 33946.

## **ARTICLE II**

The purpose for which this Association is organized is to act as the governing association of CORAL COVE SUBDIVISION, a residential subdivision located in Charlotte County, Florida. The objects and purposes for which this Association is established are solely for those exempt purposes as defined in Section 501(c)(3) of the Internal Revenue Code of 1986, and specifically do not include pecuniary profit, gain or private advantage for the incorporators, directors, or officers, or for the Association.

## **ARTICLE III**

The qualification of members and the manner of their admission shall be as follows: Any person or persons or entity that hold title in fee simple to a Lot in CORAL COVE SUBDIVISION shall, by virtue of such ownership, automatically be a member of this Association.

#### **ARTICLE IV**

The Association shall have two classes of voting membership:

A. <u>Class A</u>: Class A Members shall be all owners except the Developer, CORAL COVE DEVELOPMENT, INC., a Florida corporation (hereinafter the "Developer"), until the Developer becomes a Class A Member as more particularly provided below. Each Class

A Member shall be entitled to one (1) vote for each Lot in which the Member holds an interest. When more than one (1) person holds an interest in any Lot, all such persons shall be Members, but only one (1) vote for such Lot shall be cast as they among themselves determine in accordance with the procedures set forth in the Bylaws of the corporation.

B. Class B: Class B Members shall be the Developer, its successors and assigns. The Class B Member's approval on all matters shall be required until the earlier of such time as the Class B Member shall voluntarily authorize a transfer of its membership to Class A Membership or until Developer ceases to own more than three (3) of the Lots. At such time as the Class B Membership shall cease and be converted to Class A Membership, Developer shall be entitled to one vote for each Lot then held by Developer. Within ninety (90) days after conversion of Class B Membership into Class A Membership, a meeting shall be held at which the Developer shall formally relinquish control of the Association and the Class A Members will be entitled to elect not less than a majority of the members of the Board of Directors of the Association, subject, however, to the Developer's right to elect not less than one (1) member of the Board of Directors of the Association for as long as the Developer holds for sale in the ordinary course of business at least one (1) Lot in the subdivision and further subject to certain limitations on actions affecting the Developer as long as it owns any Lots, as set forth in the Bylaws.

# **ARTICLE V**

This Association shall exist perpetually. Should the Association be dissolved, the property consisting of the surface water management system shall be conveyed to an appropriate agency of local government, and if not accepted, then the surface water management system shall be dedicated to a similar non-profit corporation.

#### **ARTICLE VI**

The name and address of the subscriber to these Articles of Incorporation is as follows:

#### ARTICLE VII

The street address and mailing address of the initial registered office of this Association shall be 1861 Placida Road, Suite 204, Englewood, Florida, 34223. The name of the initial registered agent at such address is Miko P. Gunderson.

# **ARTICLE VIII**

The affairs of the Association are to be managed initially by a Board of three (3) Directors. The Board may be increased to any number not to exceed five (5). The Directors will be elected each year at the annual meeting of the Association as provided for in the Bylaws. The number of persons constituting the first Board of Directors shall be three (3) and their names and addresses are as follows:

The Bylaws of the Association are to be made, altered or rescinded by the members of the Association as provided for in the Bylaws.

# ARTICLE XI

Amendments to these Articles of Incorporation may be proposed and adopted at any regular or specially called meeting of the members of the Association by a majority vote of all the members. Due notice of the meeting must be given as provided for in the Bylaws.

#### **ARTICLE XII**

No part of the net earnings of this Association shall inure to the benefit of any member or individual, except through the acquisition, construction, management, maintenance, or care of property owners association property or through the rebate of the excess membership dues, fees or assessments.
