We, the undersigned, with other persons being desirous of forming a corporation for religious and charitable purposes, under the provisions of Chapter 617 of the Florida Statutes do agree to the following.

**ARTICLE 1 – NAME**

The name of this corporation is:

NEW BEGINNINGS CHRISTIAN FELLOWSHIP, INCORPORATED

**ARTICLE II – PRINCIPAL OFFICE**

The principal place of business and mailing address of incorporation shall be:

The location of this corporation shall be at 1601 Old Dixie Highway, Riviera Beach, Florida, 33404

**ARTICLES III – PURPOSE(S)**

The object, business and purpose of this corporation is to provide a place for the support of public worship, by organizing a church and enhancing all the functions and privileges necessary for religious and nonpolitical services.

The corporation shall be devoted to promoting a spirit of religious brotherhood and fellowship on a Interdenominational basis, that will uphold and maintain the constitution of United States of America and all subdivisions thereunder in maintaining law and order in community, country, state, and county.
