## ARTICLES OF INCORPORATION Of

A Firm Foundation Inc. of Jacksonville

#### Article I

Name

The name of the Corporation is A Firm Foundation, Inc. of Jacksonville

#### **Article II**

Duration

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

#### Article III

#### <u>Purpose</u>

- a. The primary purpose of this organization is charitable within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986 or such other provisions of state or federal law as may be applicable from time to time. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statues. It is not organized for private gain of any person. The specific purpose of this corporation are:
  - (1) To provide consultation & case management services to socially and economically disadvantaged young adults 16-21
  - (2) To provide independent living skills training and professional development skills to further education and enhance standards living.
- b. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.
- c. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make and distributions in furtherance of its stated purpose.

#### Article IV

#### Qualifications of Members

The qualifications of members of this corporation and the manner of their admission shall be regulated by the bylaws of said corporation.

#### Article V

Initial registered Office and Agent

#### Article VI

Initial Board of Directors

This corporation shall have **three** (3) Directors constituting the initial Board of Director's. The Bylaws shall provide the method of election of all Directors, and the number of Directors may be raised or lowered by amendment of the bylaws but shall in no case be less than three (3). This corporation reserves the right to amend or repeal any provision contained in these Articles of In corporation, or any amendment hereto, by a majority vote of the Board of Directors, and any right conferred upon the shareholders is subject to this reservation.
