The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE ONE: NAME**

The name of the corporation shall be JUNGRALA' WILDLIFE SANCTUARY, INC.

**ARTICLE TWO: PLACE OF BUSINESS**

The principle place of business and mailing address of this corporation shall be P.O. Box 65, 1670 N.W. 72 Ct., Gilchrist Co., Bell, Florida 32619.

**ARTICLE THREE: GENERAL PURPOSE**

The purpose for which this corporation is organized is to support and maintain Jungrala' Wildlife Sanctuary, Inc., a Not for Profit Corporation. The corporation is dedicated to the following:

A. The rescue, pick up of trapped, injured, distressed, orphaned, abandoned, or displaced native, or migratory wildlife, and/or exotic pets.

B. The rehabilitation of these native wild animals in accordance with the General Provisions and standards for operation as set forth and regulated by the Florida Fish and Wildlife Conservation Commission through Florida Wildlife Rehabilitation Permit # PRT682069.

C. To offer the service of Nuisance Wildlife Removal through Permit # N2005.

D. To rehabilitate and release all animals and birds, considered to be native or migratory, through Permit # PRT682069, in accordance with regulations 50 CFR Part 13 and CFR 21.27 as set forth by the Department of the Interior, U.S. Fish and Wildlife Service.

This corporation is organized to engage in any lawful

business under the laws of the State of Florida such as soliciting for funds donation, advertising, buying and selling merchandise, exhibiting, breeding and selling exotic animals, fish, and birds through license # 240035679-EPB-8420 to support this endeavor. \_

#### ARTICLE FOUR: OFFICERS

The selection of officers and directors of Jungrala' Wildlife Sanctuary, Inc. will be as follows: ..

The founder of the Corporation known as Jungrala' Wildlife Sanctuary, Inc. shall retain the position of President/Director of this Not for Profit Corporation until she is no longer able, physically or mentally, to perform in this capacity. At that time the board of directors will, by majority vote, elect a replacement after evaluation and recommendation of the candidate(s) by the board of directors. The names and titles of the officers of the corporation who shall serve until their successors are elected in accordance with the By-laws are as follows:

#### ARTICLE SEVEN: RESTRICTION OF SERVICES

Unless other permits are acquired all wildlife services

shall be restricted to Class III wildlife.

**ARTICLE EIGHT: EFFECTIVE DATE**

These Articles of Incorporation shall become effective immediately upon filing with the Department of State.
