Of
J.V. Baxter and Company, Incorporated**
In Compliance with Chapter 617, F.S., (Not for Profit)

The undersigned incorporation, for the purpose of forming a non-profit organization under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I
NAME**

The name of the corporation shall be: **J. V. Baxter and Company Incorporated.**

**Article II
PRINCIPAL PLACE OF BUSINESS
AND MAILING ADDRESS**

The principal place of business for the corporation is: 2645 N.W. 21 Avenue in the city of Oakland Park in the County of Broward. The mailing address is: 2120 N.W. 27th Street, Oakland Park, Florida 33311. The international corporation may have such other offices, either within or without the State of Florida, as the Board of Directors may designate or as the business of the corporation may require from time to time.

**Article III
PURPOSE**

The purpose for which the corporation is organized is: "not for profit" as outlined in Chapter. 617 and 496, Florida Statues.

SECTION 1. Purpose. (a) The purpose is to foster and promote a spirit of unity in Christianity creating a close association between the members of this organization and society; (b) To assist in charitable service beneficial to the best interest of the order and the society as a whole; (c) The corporation would further engage in outreach ministries: Churches, Church schools, other educational institutions, including cosmetology, providing empowerment for the community, Family care facilities, Real Estate (properties / buildings) or other business entities; to engage in businesses offering fundamental resources in human services.
