The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporations Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I

The corporation shall be named Victorious House, Inc.

ARTICLE II

The principal place of business and mailing address of this corporation shall be: Victorious House, Inc., 116 Bethune Circle, Sanford, Florida 32771.

ARTICLE III

The purposes for which the Victorious House, Inc. is organized are to eliminate domestic violence, to provide a safe environment for victims and survivors of domestic violence and their children and to bring about social change through advocacy, community education, outreach and support, such that every home itself is a safe haven for the family it shelters. We seek to counsel and re-establish women and children from abusive homes. To help them get jobs, homes, and relocate in order to establish a safe and secure environment. To provide immediate shelter and related assistance for victims of family violence and their dependents. To establish collaborative efforts between faith communities, spiritual organizations and the domestic violence control organizations to assist with the operation of this organization. The organization is organized exclusively for one or more of the following purposes: religious, charitable, literary, testing for public safety, for the prevention of cruelty to children or animals, and educational within the meaning of section 501© (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501© 3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
