# ARTICLES OF INCORPORATION of

# AGENDA CUBA INTERNATIONAL, INÓ

Pursuant to the provisions of Section 617.1006, Florida Statutes, the undersigned Florida Not for Profit Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

#### **RESOLVED:**

FIRST: That the following Amendments are hereby adopted:

Add the following to the Articles of Incorporation:

#### ARTICLE XI

## Purpose Clause

This organization is organized and operated exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt under section 501(c)(3) of the Internal Revenue Code.

# Add the following to the Articles of Incorporation:

# ARTICLE XII

# **Power Limiting Clause**

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article XI hereof.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in (including the publishing and distribution of statements) any political campaign of behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a charitable

organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a charitable organization contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

### Add the following to the Articles of Incorporation:

#### **ARTICLE XIII**

#### **Dissolution Clause**

Upon the dissolution or winding up of the Corporation, it assets remaining after payment, or provision for payment, of all debts and liabilities of this Corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under section 501(c)(3) of the Internal Revenue Code.

SECOND: That date of the adoption of the above amendments is: August 14, 2003.

THIRD: That there are no members or members entitled to vote. And that, the Board of Directors being the only body authorized to amend the Articles of Incorporation, the above Amendments (addition of Articles XI, XII and XIII) were adopted by unanimous vote of the Board of Directors on the above date.

**FOURTH:** That the President of the Board of Directors of Agenda Cuba International, Inc. submit these Articles of Amendment, under his signature and in the name of the Board, to the Division of Corporations of the Florida Department of State for their approval and recording.
