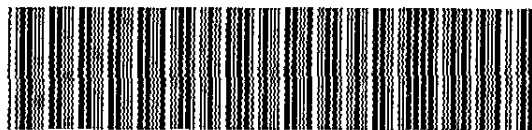

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment(s) adopted: (INDICATE ARTICLE NUMBER (S) BEING AMENDED, ADDED OR DELETED.) A motion was made by Mr. Ernest Morgan on the adoption of amendments (A&B) on page 2. It was second by Mrs. Jonne Grant. They are members of the board of glendale of Brownsville Community Development Corporation, Inc. The Articles of Incorporation was amended to include the following provisions:

A. Glendale of Brownsville Community Development Corp. Inc. is organized exclusively for charitable, religious, educational, and scientific purposes, the making of distributions to organizations that qualify as exempt under section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code.

B. Upon the dissolution of the Glendale of Brownsville Community Development Corp. Inc., assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3)

of the Internal Revenue, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

These amendments to the Articles of Incorporation of the Glendale of Brownsville Community Development Corporation Inc. was adopted by the Board of Directors at a meeting held on July 1, 2003.
