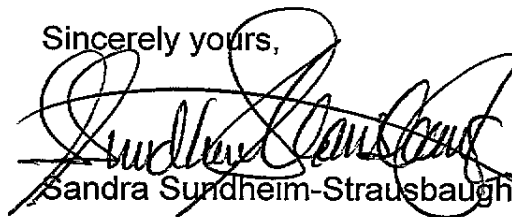

**ARTICLE I. NAME**

The name of this corporation shall be HUG, INC., a Florida non-profit corporation.

**ARTICLE II. TERM OF EXISTENCE**

This corporation is to exist perpetually.

**ARTICLE III. NATURE OF BUSINESS**

The corporation is organized in order to engage in any lawful purposes not for pecuniary profit. To provide assistance to homebound individuals, including but not limited to, providing transportation, housekeeping, and companionship.
