**ARTICLES I: NAME**

The name of the corporation shall be GEORGE E. STEELE MEMORIAL, INC.

**ARTICLE II: PRINCIPAL OFFICE**

The address of the initial registered office of this corporation is 19151 SE 135<sup>th</sup> Court, # 28, Dunnellon, Florida 34431, and the name of its initial registered agent at said address is Kenneth H. Joslin.

**ARTICLE III: PURPOSES**

This corporation is formed to operate as a CHARITABLE, BENEVOLENT, ELEEMOSYNARY, EDUCATIONAL, and RELIGIOUS, organization.
