ARTICLES OF INCORPORATION

FOR

FORT MYERS ROWING CLUB, INC.

(A Florida Not-For-Profit Corporation)

The undersigned, acting as incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be: FORT MYERS ROWING CLUB, INC.

ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be:

ARTICLE III PURPOSE

The purpose for which this organization is organized is exclusively educational and to foster national and international amateur sports competition within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

- b) To foster and promote club members competitive rowing on the local, regional, national and international level.
