ARTICLES OF INCORPORATION POD 9 AT MONARCH LAKES PROPERTY OWNERS ASSOCI

Pursuant to the provisions of Chapter 617 of the Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- The name of the corporation is Pod 9 At Monarch Lakes Property Owners Association, Inc. (the "Corporation").
- 2. The original Articles of Incorporation for the Corporation were filed with the Secretary of State of Florida on October 19, 2000.
- The following Amendments to the Articles of Incorporation were adopted by an affirmative vote of a majority of the Voting Members of the Corporation and all of the Directors of the Corporation on November 15, 2000, in the manner prescribed by the Articles of Incorporation of the Corporation and the provisions of Chapter 617, Florida Statutes:

**RESOLVED THAT** the name of the corporation as it appears in Article 1 of the Articles of Incorporation of the Corporation is "Pod 9 At Monarch Lakes Property Owners Association, Inc." is hereby amended to read as "Mariposa Isles At Monarch Lakes Homeowners' Association, Inc."

- 4. All references in the Articles of Incorporation to the "Association" shall hereafter refer to Pod 9 At Monarch Lakes Property Owners Association, Inc.
- 5. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.
