## ARTICLES OF INCORPORATION

### THE CRAWFORD HOUSE, INC. of Jacksonville

ONE: The name and address of this principal corporation is The Crawford House, Inc. located at 406 Cranes Landing Court, Jacksonville Florida 32216, in Duval County. The principal office is also the mailing address. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for, charitable and educational purposes to aid the poor and disadvantaged individuals and families toward a life of self-sufficiency. The programs will consist of but shall not be limited to: Adult Assisted Living Facilities, Adult Day Centers, Care for Children with disabilities, Teen Job Placement, Land Acquisition, Counseling, Community Employment, Seminars, Health Fairs, Aids/HIV Education, Drug Awareness, Rehabilitation of clients back into society, and other programs to aid those in need.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.

- (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.

EIGHT: On the dissolution or winding up of the corporation, its assets remain-after payment of, or provision for payments of, all debts, and liabilities of this corporation, shall be distributed to a non-profit fund, foundation, or corporation, which is organized and operated exclusively for, Educational and Charitable under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future government, or to a state or local government for a public purpose. Any such asset not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such organized and operated exclusively for such purposes.
