

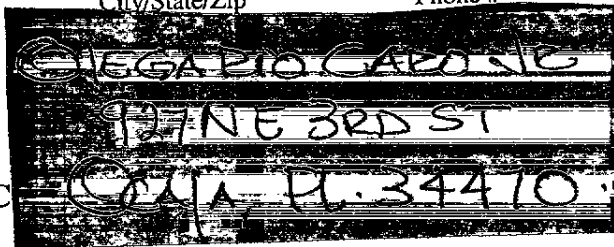

ARTICLES OF INCORPORATION
OF
IGLESIA CRISTIANA, LACUEVA DE ADULAM, INC.

ARTICLE I: NAME

The name of the corporation shall be Iglesia Cristiana, La Cueva de Adulam, Inc.

ARTICLE II: DURATION

The duration of this corporation shall be perpetual.

ARTICLE III: INITIAL REGISTERED
OFFICE AND AGENT

The address of the initial registered office of this corporation is 927 NE 3rd Street, Ocala, Florida 34470 and the name of its initial registered agent at said address is Olegario Caro Jr.,

ARTICLE IV: PURPOSES

This corporation is formed to operate as a religious and non profit organization, including, but not limited to, the following purposes:

1. To preach the Gospel of our Lord Jesus Christ and care for the well-being of mankind through the world.
2. To provide Christian education, health care, ministerial and educational services in needy areas here and of the world.
3. To establish and maintain educational facilities, arts Christian facilities, health care facilities, clinics, drugs and alcohol recoveries facilities for men and women and other health providing facilities, as approved by the board of directors.

4. To establish educational facilities for Christian Bible teaching and training of missionaries. To ordain ministers and reverends to promulgate the teachings of God's Gospel.
5. To establish churches, teaching institutions, including research and missions for the promotion of the Christian Gospel locally and throughout the world.
6. To collect the distribute funds for the accomplishment of the purposes.
7. To operate exclusively for such other charitable and religious purposes as will qualify this corporation as an exopt organization under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), including for such purposes the making of distributions to organizations that qualify as tax-exempt organizations under said Code.

ARTICLE V: CORPORATE POWERS

The corporate powers of this corporation are as follows:

1. To make distribution to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).
2. To adopt and use a common corporate seal and alter the same; provided, however, that such seal shall always contain the words "Corporation Not for Profit."
3. To elect or appoint such officers and agents as its affairs shall require and allow them reasonable compensation.
4. Iglesia Cristiana, LaCueva de Adulam, Inc. shall conduct its affairs within the meaning of the Statutes and laws of the State of Florida and of the United States of America, as now existing or as hereafter amended or modified.
Inconsistencies and interpretation of Bylaws shall be changed, amended or repealed as necessary for the proper functioning of the corporation.
5. Membership of the corporation shall be composed of those people who become members and accept the rules and regulations which is belief and faith in a supreme being and in compliance to the principles of sound doctrine of the Christian principles as taught by the Lord and savior Jesus Christ. The management of the corporation shall be vested of the Board of Directors of not less than three (3) nor more than fifteen (15).

6. To contracts and incur liabilities, burrow money at such rates of interest as the corporation may determine. Issue its notes, bonds and other chattel obligations and secure its obligations either by mortgage or pledge of all or any of its property or income. To solicit and receive donations, endowments, to buy, own and sell real estate and personal property, issue promissory notes in the corporate name, to mortgage any property possessed by it and do any and all other things necessary to the proper management of the corporation.
7. To conduct its affairs, carry on its operations, have offices throughout the United States of America and other parts of the world, and exercising the powers granted pursuant to the laws of the States of Florida and the United States of America.
8. To purchase, take, receive, lease, take by gift, devise or bequest or otherwise acquire, own, hold, improve, are or deal in and with real or personal property, or any interest therein, wherever situated either locally or in any other parts of the world.
9. To acquire, enjoy, utilize and dispose of patents, copyrights and trademarks and any license and any other rights or instruments thereafter or hereunder appertaining.
10. To purchase, take, receive, subscribe, for or otherwise acquire, own, hold, vote, use employ, sell, mortgage, lend, pledge or otherwise dispose of and otherwise use and deal in and with shares and other interests in or obligations of other domestic or foreing corporations, whether for profit or not for profit, associations, partnerships or individuals, or direct or inderect obligations of the United States of America or of any other governmental district, municipality or any instrumentality thereof.
11. To lend money for its corporate purposes, invest and reinvest its funds and take and hold real and personal property as security for the payment of funds so loaned or invested.
12. To make donations for the public welfare or for religious, charitable or other similar purposes.
13. To have and exerise any and all other powers necessary or convenient to effect any or all othe purposes for which the corporation is organized, including all of the rights, powers, privileges and immunities accorded by law to similar charitable non-profit organizations, with such additional rights, powers, priviledges and immunities as may be necessary, proper, or incident to the conduct of business aforesaid, and as may be inherent in or allowed to like non-profit charitable corporations under the laws of the State of Florida as they now exists or may hereafter exist.
14. To have the right, power and authority to make rules and regulations, adopt by-laws, hold regular meetings and select such officers as they think necessary and as proper; to delegate any part of its authority or any portion therof to committees, person or subordinate bodies; to increase the number of members of the Board to any amount not to exceed or be less than the maximum and minimum prescribed by this charter; to fill vacancies in their number which my from time to

time exist by virtue of the expiration of term of office, death, resignation, or increase in the number of directors, or otherwise; to fix the term of their own offices and to of their successors; and in general to have and to exercise all powers of management and direction for the affairs of this corporation.

ARTICLE VI: MEMBERSHIP QUALIFICATIONS

No persons may become members of directors of this corporation other than the incorporating directors or their successors appointed or elected appointed as provided in the Bylaws or such other persons as may be elected or appointed as provided in the Bylaws. The Chairman of the Board, President, and Vice President must be members of the Board of Directors, but other officers may be elected or appointed who are not members of the Board of Directors.

ARTICLE VII: BOARD OF DIRECTORS

ARTICLE VIII: AMENDMENTS

The Bylaws and Articles of Incorporation can be amended in the manner provided by the laws of the State of Florida at the time of the amendment.

ARTICLE IX: EARNINGS AND ACTIVITIES

1. No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof. No substantial part of the activities of this corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and this corporation shall not participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these Articles of Incorporation, this corporation shall be carried on by:

a) A corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law), or

b) By a corporation, contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

2. The Board of Directors may cause this corporation to solicit, collect, receive, accumulate, administer and disburse funds in such a manner as will, in the sole discretion of the Board of Directors, most effectively operate to further the purpose of this corporation.

ARTICLE X: DISSOLUTION

Upon dissolution of Iglesia Cristiana, LaCueva de Adulam, Inc., and the winding up of its affairs, the assets of this corporation shall be distributed exclusively for charitable or religious purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1954, as amended, or any superseding section.

IGLESIA CRISTIANA, LA CUEVA DE ADULAM, INC., BYLAW

OCTOBER, 2000

1. IGLESIA CRISTIANA, LA CUEVA DE ADULAM, INC., SHALL BE GOVERNED BY A BOARD OF DIRECTORS CONSISTING OF: PRESIDENT, VICE PRESIDENT, SECRETARY, TREASURER, AND ONE DIRECTOR AT LARGE.

2. BUSINESS SHALL BE CONDUCTED SO LONG AS THREE (3) OR MORE DIRECTORS ARE PRESENT. THE PRESIDENT OF IGLESIA CRISTIANA, LA CUEVA DE ADULAM, INC., SHALL BE CHARGED WITH CALLING ALL BOARD OF DIRECTORS MEETINGS. THE BOARD OF DIRECTORS SHALL BE IN SESSION A MINIMUM OF THREE (3) TIMES ANNUALLY.

3. THE BOARD OF DIRECTORS SHALL OVERSEE ALL FINANCES, PROJECTS AND SHALL GIVE DIRECTION TO THE PRESIDENT IN CARRYING OUT ALL PROJECTS OF IGLESIA CRISTIANA, LA CUEVA DE ADULAM, INC.

4. IGLESIA CRISTIANA, LA CUEVA DE ADULAM, INC., SHALL GIVE PRIMARY ATTENTION TO THE SPREADING THE LOVE OF JESUS THROUGH PRAYER AND WORSHIP, PERSONAL EVANGELISM, GROUP MINISTRIES, EDUCATIONAL AND ART ACTIVITIES, SCIENTIFIC RESEARCH AND MEDICAL MINISTRIES.

5. CHRISTIANS INSTRUCTION, PRAYER, BIBLE STUDIES, HISTORY, ARTS AND ADVANCE SPECIALTIES SHALL BE ON GOING PROJECTS OF IGLESIA CRISTIANA, LA CUEVA DE ADULAM, INC..

6. IGLESIA CRISTIANA, LA CUEVA DE ADULAM, INC., THROUGH THE PRESIDENT SHALL GIVE PRIMARY ATTENTION TO SPONSORING MINISTRY TEAMS, EDUCATIONAL AND RESEARCH TEAMS, WORK TEAMS AND HEALTH ACTIVITIES TEAMS INTO ALL PARTS OF THE WORLD AS CRITICAL NEEDS ARISE.

7. THE BOARD OF DIRECTORS SHALL SERVE WITHOUT PAY AND SHALL SERVE INDEFINITELY. PROVISIONS SHALL BE MADE FOR TRAVEL EXPENSES AND SALARY OF THE PRESIDENT-EXECUTIVE DIRECTIVE DIRECTOR AS SUFFICIENT FUNDING IS AVAILABLE. THIS SALARY SHALL NOT EXCEED FIFTEEN PERCENT (15%) OF THE OVERALL BUDGET.

8. IGLESIA CRISTIANA, LA CUEVA DE ADULAM, INC., SHALL HAVE AN ANNUAL MEETING FOR THE PURPOSE OF PLANNING THE ANNUAL BUDGET, REVIEWING PREVIOUS YEARS ACCOMPLISHMENTS AND ESTABLISHING GOALS FOR THE ENSUING YEAR. THE ANNUAL MEETING SHALL BE HELD THE FIRST WEEK OF JANUARY AND SHALL BE CALLED INTO SESSION BY THE PRESIDENT.

9. ALL IGLESIA CRISTIANA, LA CUEVA DE ADULAM, INC., INC., SHALL BE OPENED AND CLOSED IN PRAYER

10. THE BOARD OF DIRECTORS MAY ESTABLISH A BOARD OF ADVISORS WHO MAY OFFER DIRECTION AND ENCOURAGEMENT TO THE PRESIDENT AND DIRECTORS.

11. THE PRESIDENT OF IGLESIA CRISTIANA, LA CUEVA DE ADULAM, INC., SHALL NAME SUFFICIENT COMMITTEE CHAIRMEN IN ORDER OT CARRY FORTH SUCCESSFULLY ALL THE PROGRAMS OF IGLESIA CRISTIANA, LA CUEVA DE ADULAM, INC.

12. THE FUNCTION OF IGLESIA CRISTIANA, LA CUEVA DE ADULAM, INC., SHALL BE TO ELEVATE AND GLORIFY OUR LORD JESUS CHRIST SO AS TO FOLLOW AND SPREAD HIS TEACHINGS OF TRUTH, LOVE, AND SALVATION THROUGH THE MINISTRIES OF CHRISTIAN PRINCIPLES, AND "OBEYING HIS WORDS" AS WRITTEN IN THE CHRISTIAN GOSPELS OF JOHN 14:6 AND 23-27, AND MATTHEW 28: 19-20.
