ARTICLES OF INCORPORATION

OF

The undersigned, as incorporator, desiring to organize a corporation not for profit under Chapter 617, Florida Statues, sets forth the following:

ARTICLE I

The name of the corporation shall be First New Zion Baptist Church, Inc.

ARTICLE II

The duration of the corporation shall be perpetual. Commencement shall be on the date and at the time of the filing of these Articles with the Division of Corporations of the Florida Department of State.

ARTICLE III
