The undersigned, acting as incorporator of a non-profit corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

SECOND: The period of its duration is perpetual.

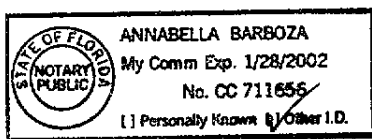
