ARTICLES OF INCORPORATION

Pursuant to Chapter 617.0202, Florida Statutes, the following articles of incorporation are set forth:

Article I:

Article III:

The purpose of the corporation is to provide the following:

1. Provide free training in certain studio, musical, and performing arts, for children and adults who are physically, mentally, and economically challenged.
2. Provide college tuition for individuals who meet certain criteria and the approval of the majority of the directors.
3. Funds will be generated through donations and the marketing of museum quality fine art produced by the associates and students. Support will also be obtained through the sale of tickets to events and benefits. Donations will be sought from anyone who desires to perpetuate the learning that is derived from the arts.
4. All student applicants will be reviewed by the directors and the selection process will always require a majority vote.

Article IV:

The directors of this corporation shall be elected by ballot, for the term of one year, at the annual meeting of directors, except as hereinafter otherwise provided for filling vacancies. The directors shall be chosen by a plurality of the votes of the directors, voting either in person or by proxy, at such annual election as provided by the laws of Florida.
