Therefore, as of today's meeting, CCAE will no longer exist as a corporation. We thank God for His help and guidance, and are content to bring matters to a close.

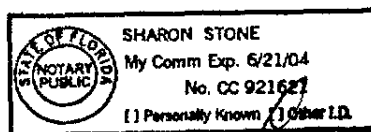
On this date all files were reviewed, discarded or filed for the recommended seven-year tax review period.


Articles of Dissolution
