*Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida non for profit corporation adopts the following articles of amendment to its articles of incorporation:*

**ARTICLE III PURPOSE**

**This church is organized for the purpose of building bridges with our community and helping then become fully devoted followers of Christ.**

**Notwithstanding any other provisions of these articles, this church is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code of 1986, and shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under IRC 501(c)(3) or corresponding provisions of any subsequent tax laws.**

**No part of the net earnings of the organization shall inure to the benefit of any member, trustee, director, officer of the organization, or any private individual (except that reasonable compensation may be paid for services rendered to or for the organization), and no member, trustee officer of the organization or any private individual shall be entitled to share in the distribution of any of the organization's assets on dissolution of the organization.**


**No substantial part of the activities of the organization shall be carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by IRC 501(h) or participating in, or intervening in (including the publication or distribution or statements), any political campaign on behalf of or in opposition to any candidates for public office.**


**In the event of dissolution, all of the remaining assets and property of the organization shall after payment of necessary expenses thereof be distributed to such organization as shall qualify under section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent Federal tax laws, or to the Federal government or State or local government for a public purpose, subject to the approval of a Justice of the Supreme Court of the State of Florida.**

**There are no members entitled to vote on this amendment to the Articles of Incorporation of CrossPoint Church, Inc.**
