FIRST: The name of the corporation is HORSESHOE LAKE & CREEK HOMEOWNERS ASSOCIATION, INC.


SECOND: The Articles of Incorporation were filed on October 25, 2000.

THIRD: The corporation has not commenced to conduct its affairs.


FOURTH: No debts of the corporation remain unpaid.

FIFTH: The Adoption of Dissolution was authorized by all of the directors.




