### ARTICLES OF INCORPORATION OF

### GAY AND LESBIAN COMMUNITY CENTER OF SOUTHWEST FLORIDATE CORREDATES

The undersigned incorporator, for the purpose of forming a not for profit corporation under the Florida Not For Profit Corporation Act, hereby adopts the following Articles of Incorporation.

#### ARTICLE I NAME

The name of the corporation shall be: GAY AND LESBIAN COMMUNITY CENTER OF SOUTHWEST FLORIDA,INC.

#### ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

#### ARTICLE III PURPOSE
