ARTICLES OF INCORPORATION

OF

NEW HOPE CHRISTIAN CHURCH OF BRADENTON, INC.

1. NAME. The name of this corporation is New Hope Christian Church of Bradenton, Inc.
2. CAPITAL STOCK. The corporation is a corporation not for profit under Chapter 617, Florida Statutes. The corporation shall have no capital stock and no member shall have any right or title to any asset of the corporation.
3. ADDRESS. The principal place of business and mailing address for the corporation is 1205 63rd Street West, Bradenton, Florida 34209.
4. PURPOSE. The purpose for which the corporation is organized is to be a healthy church which presents the unchanging truth of God's good news in a way which is relevant and meaningful to our culture in order to effect changed lives by the power of Christ.
5. DURATION. This corporation shall have perpetual existence, and its existence shall commence on the date of the execution and acknowledgment of these Articles of Incorporation.
6. MEMBERSHIP. Individuals who have demonstrated their support for this corporation and its purpose shall be eligible for membership.
7. NUMBER OF DIRECTORS. The corporation shall have five directors, initially. The number of directors may be increased or diminished from time to time, by by-laws by the directors, but shall never be less than

three. The directors shall be elected by a majority vote of the members entitled to vote thereon.

8. **INITIAL DIRECTORS.** The name and street address of each member of the initial Board of Directors is: 1. Dr. Willis Stogsdill, 4814 63rd Drive West, Bradenton, Florida 34210; 2. Richard K. Curlee, 3210 15th Avenue West, Bradenton, Florida 34205; 3. Jeff Mohler, 5317 17th Street West, Bradenton, Florida 34207; 4. Robert Sharpin, 2007 48th Street West, Bradenton, Florida 34208; and 5. Dr. George Fisher, 1205 63rd Street West, Bradenton, Florida 34209.
9. **INCORPORATOR.** The name and address of the incorporator is Dr. Willis Stogsdill, 4814 63rd Drive West, Bradenton, Florida 34210.
10. **INITIAL OFFICERS.** The names of the officers of the corporation who shall hold office until their successors have been elected and qualified is: President- Dr. George Fisher, Vice-President- Robert Sharpin, Secretary- Richard K. Curlee, and Treasurer- Dr. Willis Stogsdill.
11. **INITIAL REGISTERED OFFICE AND AGENT.** The street address of the initial registered office of the corporation is 4814 63rd Drive West, Bradenton, Florida 34210 and the initial registered agent of the corporation at that address is Dr. Willis Stogsdill.
12. **AMENDMENTS.** These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the members and approved at a

meeting of the members by a majority of the members entitled to vote
thereon.
