**ARTICLES OF INCORPORATION**

**Know All Men By These Presents:** That the undersigned incorporators does hereby incorporate a corporation under the provisions of Chapter 617, Florida Statutes, for Not for Profit with and under the following Articles of Incorporation:

**ARTICLE I**
