ARTICLES I


In accordance with article ten of our Articles of Inc. we hereby make the following amendment C from 503-4-351 (9-84) to comply with section 501(C)(3) of the federal code.

- A. Notwithstanding any other provisions of these articles, the purpose for which the Corp. is organized are excluded, religious charitable and educational within the meanings of section 501 (C) (3) of the Internal Revenue Code 1954 or the corresponding provision of any future United State Internal Revenue Law.
- B. Notwithstanding any other provision of these articles this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501 (C) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law.
- C. In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in section 501 (c) and 170 (c) (2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State or local government for exclusive public purpose.
