- ARTICLE I** The name and address of this principal corporation is StarrLight Trucking, Inc., 1390 South Adelle Ave., DeLand, Fl. 32720. Volusia County. The corporation is organized pursuant to the **FLORIDA** Nonprofit Corporation Code.
- ARTICLE II** This corporation is a Nonprofit Public Benefit Corporation and is not organized for the private gain of any person. The corporation is organized under the **Nonprofit Public Benefit Corporation Law** for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consists of, but shall not be limited to: Job Training, Job Placement, Land Acquisition, Housing, Employment, Literacy, Counseling, Temporary Shelter, Teenage Pregnancy, Family Planning, Mentoring, Substance Abuse and Awareness, and AIDS Awareness programs to aid those in need.
- ARTICLE III** The duration of this corporation shall be perpetual, no stock and shall have no members.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a

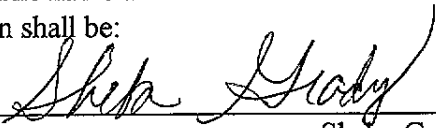
