ARTICLE I

The name of the corporation is **PROGRESSIVE C. LEARNING CENTER, INC.**

ARTICLE II

The principal address, and mailing address of the corporation is: P.O. Box 3906, Hollywood, Florida 33083.

ARTICLE III

The purpose for which this corporation is organized is: to try to convey clearly and concretely as possible the scope of community backing for the proposed charter school and its founding board. Pre-K through first grade. To develop an individualized plan of support and services that identifies the preferences, interests, talents, attributes and needs of an individual and provide for the education of exceptional students, ADD, behavior/mental health issues. Help the families of the children as well along with the following objectives of the organization: Child care, education, foster care, youth outreach, women at risk (minorities), victims of crimes, men's outreach, senior citizens/disabled, homeless, emergency repair.

ARTICLE IV

The manner in which the Directors of the corporation are to be elected is as follows: Elections shall be made by majority vote of the Directors. This provision may be ratified by new laws adapted by the Board of Directors.

The number of directors constituting the initial board of directors is three (3), and the name and address of the person or persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and qualified are:

ARTICLE V

The Corporate Powers shall not be limited. This Corporation shall have full exercise of all powers necessary to carry out the purposes and objectives of this corporation, as may be determined by the Board of Directors, in accordance with Section 617.0302, Florida Statutes.

The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.

ARTICLE VI

The street address of its initial registered office is 5341 S.W. 25 Street, Hollywood, Florida 33083 and the name of its initial registered agent at such address is Rosalie Jenkins.
