# ARTICLES OF INCORPORATION OF The American Youth Foundation Inc.

The undersigned persons, acting as incorporators of a corporation organized under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

# ARTICLE I CORPORATE NAME

The name of this corporation is The American Youth Foundation, Inc..

#### ARTICLE II INITIAL PRINCIPAL OFFICE

The mailing address of the corporation's initial principal office is:

#### ARTICLE III SHARES

The total number of shares which the corporation shall have authority to issue is 100 shares with no par value .

### ARTICLE IV PURPOSE

The purpose of the corporation is to operate as a Not-For-Profit organization to provide education and charitable services for the youth of the community.

#### ARTICLE V DIRECTORS

The person/s constituting the initial Board of Directors is Donald D. Tietig, Donald Campbell, and Gloria Hale. After the initial Board of Directors, the Board shall consist of such number of directors as shall be determined by the shareholders at their Annual Meeting at which time the Directors are appointed &/or elected.

#### ARTICLE VI LIABILITY OF DIRECTORS

To the fullest extent permitted by law, no director of this corporation shall be personally liable to the corporation or its shareholders for monetary damages for breach of any duty owed to the corporation or its shareholders, except that a director may be held personally liable for:

- 1. breaches of the duty of loyalty,
- 2. acts or omissions not in good faith of which involve intentional misconduct or a knowing violation of law,
- 3. declaration of unlawful dividends or unlawful stock repurchases or redemptions,
- 4. a transaction from which the director derives an improper personal benefit.

Any director or officer who is involved in litigation or other proceeding by reason of his or her position as a director or officer of this corporation shall be indemnified and held harmless by the corporation to the fullest extent permitted by law.

#### ARTICLE VII OTHER PROVISIONS

Director or Officer Interest. In the absence of fraud, no transaction between (a) this corporation and (b) any other association, corporation or any director or officer of this corporation individually, shall be affected by the fact that any director or officer of this corporation is individually a party to the transaction or is interested in or is a director or officer of such other association or corporation.

Execution of Written Instruments. All instruments that are executed on behalf of the corporation which are acknowledged and which affect an interest in real estate shall be executed by the President or Vice-president and the Secretary or Treasurer. All other

instruments executed by the corporation, including a release of mortgage or lien, may be executed by the President or the Vice-president. Notwithstanding the preceding provisions of this section, any written instrument may be executed by any officer or agent that is specifically designated by resolution of the Board of Directors.

#### ARTICLE VII-A

Should this corporation accrue any assets over the entire life of the corporation and, if this coorporation, whether by default or intentional nature, should dissolve, any and all assets are to be donated to the Shands Children's Hospital in Gainesville, Florida, which is a not-for-profit corporation. No assets will become the property of any individual or individuals.
