ARTICLES OF INCORPORATION

<u>OF</u>

CASTILLO I AT TIBURON CONDOMINIUM ASSOCIATION, INC

(A NON-PROFIT FLORIDA CORPORATION)

<u>ARTICLE I</u>

The name of this corporation is Castillo I at Tiburon Condominium Association, Inc.

ARTICLE II

The purpose for which this corporation is organized is to act as the governing association of the proposed Castillo I at Tiburon, A Condominium, located in Naples, Collier County, Florida (the "Condominium") according to the Declaration of Condominium for Castillo I at Tiburon to be recorded in the Public Records of Collier County, Florida (the "Declaration").
