The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation shall be **Lauderhill Business Alliance, Inc.**

ARTICLE II

Principal Place of Business and Mailing Address

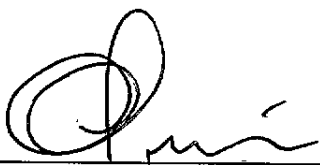
