

**ARTICLE I: NAME**

The name of this not for profit corporation is Precision Archers, Inc.

**ARTICLE II: PRINCIPAL OFFICE**

The principal office for doing business and mailing address of this not for profit corporation is:



**ARTICLE III: PURPOSE**

The purpose for which this not for profit corporation is organized under Chapter 617 of the Florida Statutes is to support all forms of archery that are legally allowed in the State of Florida. In doing so, this not for profit corporation shall be associated with the National Field Archery Association (NFAA), the National Archery Association (NAA), and the Florida Archery Association (FAA) and adhere to their goals and rules. The primary means to accomplish this support shall be through instructional effort.

**ARTICLE IV: MANNER OF ELECTION**

The manner in which directors are elected is by unanimous agreement of the initial Board of Directors (Dr. Peter E. Bright, Donald J. White, and Katsuko White) or their successors. Additional directors, officers and members must be dues paying members of NFAA, NAA, and FAA. Any changes to the Articles of Incorporation or Bylaws of this not for profit corporation must be a unanimous decision by the Board of Directors. There must be at least one meeting of the Board of Directors every five (5) years.
